Washington, DC, July 2, 2019 — Local health department leaders, public health partners, and invited guests will convene at the 2019 National Association of County and City Health Officials (NACCHO) Annual Conference, the largest gathering of local health officials in the United States, July 9-11 in Orlando, Florida. NACCHO, the voice of the nation's nearly 3,000 local governmental health departments, is the only national organization that holds meetings to address needs specific to local health departments. This year's conference theme is *Improving the Nation's Health through Public and Private Partnerships*. For the first time, NACCHO's four plenary sessions will be available to the media via live streaming. The media are also invited to attend the lively Town Hall discussions, including the Drug Overdose Town Hall on Thursday, July 11 at 9:15am.

In addition, the media are invited to join attendees on a one-mile guided walk on Thursday, July 11 at 6:00am.

More than 1,000 attendees from around the country will gather to share best practices and hear from national and regional leaders, as well as local, state, and federal, health officials about the future of public health and to address today's pressing public health challenges.

Over the years, the public health workforce has become a tapestry of multi-sectoral agencies working to effectively address and mitigate public health issues across the country. The opening general session will discuss how nontraditional workforces are teaming up with public health agencies to make communities healthier, explore ways in which the skills of these different workforces are interchangeable, and highlight the need to invest in strategic skills that can be used across sectors.

Achieving health goals requires effective engagement by public health professionals with partners in other sectors, including education, housing, transportation, and business. However, it can be challenging for public health to create partnerships with leaders in other sectors, as many of these leaders struggle to see the connection between public health and their own goals.

In the second general session, presented by the de Beaumont Foundation, speakers Soledad O'Brien, Chief Executive Officer of Starfish Media Group; Nat Kendall-Taylor, PhD, Chief Executive Officer of the FrameWorks Institute; Shelia Hiddleson, RN, MS, Health Commissioner for the Delaware General Health District in Ohio and PHRASES Fellow; and moderator John Dreyzehner, MD, MPH, FACOEM, Former Commissioner of Health in Tennessee, will discuss the Public Health Reaching Across Sectors (PHRASES) project and share new research that documents the gaps between how public health experts and leaders in other sectors view public health and cross-sector collaboration, and present new strategic tools for more effectively framing and communicating the value of public health. https://www.phrases.org/

Across the globe, regardless of location, and no matter the issue at hand, public health practitioners have ultimately the same goal: to protect the public's health and well-being by

improving the lives of their community members and protecting them from illnesses or other issues that would impact their health and lead to premature death. While the mission is universal, the specific strategies and tactics are not. While some of this is due to the unique specifics of each locale, some of it stems from a lack of communication, sharing, and diffusion of best practices across the global health system. To highlight the importance of sharing across the global health system, this plenary session at NACCHO Annual 2019 would convene key partners in their quest to integrate global health and domestic health here in the United States. Through this plenary session, attendees will: (1) learn specifics on how learnings from abroad have the capacity to improve health of local communities in the United States; (2) understand better how establishing a culture of health does not need to stop at boundaries; and (3) appreciate that global solutions applied locally can be innovative, cost-effective, and improve measurable health outcomes.

Public private partnerships (P3s) in health are one of the most promising models of intervention in delivering innovative, successful, and sustainable health initiatives. By combining public interest and need with private sector entrepreneurial approaches, P3s have spurred new approaches in the way public health achieves its mission. A model practice of how this is done is best seen in the national efforts of the Blue Zones Project (BZP). BZP is a community-focused health promotion initiative that leverages policy-based approaches designed to have an impact on social and environmental factors to enable healthy choices to be the easy choice.

The Blue Zones Project was born out of National Geographic explorer Dan Buettner's eight-year examination of communities across the globe where people were found to be healthier, happier, and living longer. A team of researchers confirmed the common characteristics that enable these communities to support healthier outcomes. As a result of this research, BZP has partnered with multiple public and private-sector organizations from public health departments to healthcare systems to corporations to philanthropic

organizations to demonstrate how this intervention model can have measurable impact in lowering healthcare costs, improving health outcomes, and supporting enhanced community livability. These results reinforce the need for P3s in strengthening the capacity of public health in fulfilling its mission to support healthier people and communities.

This town hall will explore the important role local health departments play as community health strategists in facilitating partnerships with the public and private sectors to bolster the technical expertise, funding, and innovation required to address increased illicit drug use and the opioid epidemic in the United States. As drug addiction takes its toll, the country's rapidly evolving drug overdose crisis shows no signs of slowing down. Efforts focused on reducing the number of provider-prescribed opioids have inadvertently driven patients dependent on opioids to illicit heroin and fentanyl, causing a sharp increase in opioid-related deaths. The rapid rate of drug overdose deaths involving multiple drug (polydrug) abuse requires a multifaced, all-hands-on-deck approach to protect communities. Recent data suggests a need to widen prevention and response efforts on fentanyl and other synthetic opioids to include other substances, such as cocaine and methamphetamine.
